Permission for "Special Events" that would other wise breach any of these rules may be granted only by the Township Board.

RULES:

- Monitor Park is open from May 1 through September 30. 1)
- 2) Park hours are 8:00 a.m. to dusk.
- 3) No driving on the lawn for any reason.
- No commercial or fundraising uses allowed. 4)
- 5) No alcoholic beverages allowed on park property.
- **6)** Public address systems, loud speakers, etc., are not allowed.
- 7) Fireworks or firearms of any kind are not allowed.
- 8) No ground fires. Fires to be built in grills for cooking purposes only.
- 9) Defacing or removal of park property, including plants, is prohibited.
- 10) Speed limit within the park is not to exceed 10 m.p.h.
- 11) No off road vehicles, motorcycles or snowmobiles allowed.

Bounce House Policy

Anyone wishing to put up a Bounce House or similar inflatable in Monitor Township Parks is required to do the following:

- 1. Deliver to the Township a one million dollar liability insurance policy related to placement of the bounce house.
- 2. Provide your own source of electricity (generator) for its operation. Board approved 5-11-15
