# CHARTER TOWNSHIP OF MONITOR COUNTY OF BAY, MICHIGAN

#### ORDINANCE NO. 58-A

AN ORDINANCE AMENDING ORDINANCE NO.58 SO AS TO PROVIDE THAT OWNERS OF DOWNED OVERHEAD LINES SHALL BE EXEMPT FROM THE PAYMENT OF COST RECOVERY CHARGES FOR THE FIRST HOUR OF TIME DEVOTED TO SUCH EMERGENCY RESPONSES.

#### THE CHARTER TOWNSHIP OF MONITOR ORDAINS:

## SECTION I.

Section V of Ordinance No. 58, entitled Exemptions From Liability, shall henceforth be amended by the addition of Subsection F. which shall provide as follows:

F. Non-governmental owners of downed overhead power, electrical, transmission, telephone or cable lines shall be exempt from the reimbursement of charges for the first hour of time devoted to such an emergency response. In the event that such an emergency response is completed within one hour's time of the arrival of the Monitor Fire Department, there shall be no charge for the response. For each hour after the first hour at such an emergency the non-governmental owner shall be charged in accordance with the Cost Recovery Fee Schedule adopted, and from time to time amended by the Monitor Township Board.

### SECTION II.

All other terms and conditions of Ordinance No. 58 shall remain unchanged.

# SECTION III. PUBLICATION AND EFFECTIVE DATE

This Ordinance shall, upon adoption, be published in a newspaper circulated within the Charter Township of Monitor, Bay County, Michigan, and shall take effect immediately upon publication.
