The Supervisor, K. Malkin called the meeting to order at 7:00 p.m.

Public Input opened at 7:01 p.m.

Jack C. Frank, spoke about the condition of several roads in the Township that are in need of repairs. K. Malkin responded, stating that the water and storm water project would need to be completed first, and there is a plan to repair the affected roads.

Vaughn Begick announced that Bay Veterans Foundation will be hosting a groundbreaking ceremony of the Gold Star Family Memorial Monument on Saturday, April 29th at 3:00 pm, at the Cityøs Battery Park and has invited the Board to attend. He also mentioned that he had attended a meeting this morning with the Michigan Association of Counties Health and Human Services Committee regarding the pending marijuana legislation.

Kawkawlin River Forestry Grant Update

John Roszatycki, from KRWA Watershed, and Kevin Wilson, of the Bay County Conservation District presented a proposal to provide services under the US Forestry Grant. Plantings and restoration activities would be included throughout the 2-year project. Pike inquired if the group would provide cover crop informational posters or brochures describing the nature of the program and types of plantings. Mr. Wilson stated that they will be providing a slideshow presentation to the Board before planting begins in the fall, and literature will be provided to the Township for residents with questions. There was discussion regarding improvements being made to the kayak dock at Herbert Steih Park.

Motion by Reder supported by Brandt to approve the proposal submitted by the Bay County Conservation District as a sub-contractor to deliver the BMP portion of the US Forestry Grant in the amount of \$156,000.00.

Fire Department ó Fire Apparatus Proposal

John R. Kramer, Chief, of the Monitor Township Fire Department presented the Township Board with a proposal from reputable HME, Incorporated for the purchase of one (1) HME Ahrens-Fox Pumper on HME Four Door Cab & Chassis with applicable lifesaving equipment. This will replace the 1998 that is currently in service, but not in serviceable condition. In-service vehicles and equipment are required to be brought up to code at 20 years. Usable equipment on the 1998 would be transferred to the new apparatus. In 2007 the first truck was replaced and the second replacement occurred in 2014. Both units were purchased through HME, Inc. This particular unit would be considered their highway truck which is designed to respond to automobile accidents and collisions that require extrication. This unit would have upgraded electric tools, cutter, spreader and a ramp. The current tools on the truck to be replaced will be utilized in an efficient manner on existing trucks in service. Chief Kramer explained the various cost saving methods that were used in project specification and their basis for their desire to purchase the unit from HME, Inc. for delivery in 2018. The apparatus would be completely funded through a previously approved millage.

Brandt commented stating that we would need to make sure that no Ordinance exists which mandates an RFP process. Malkin contends it could be approved subject to approval of our Township attorney.

Motion by Reder supported by Walsh to accept the proposal submitted by Chief Kramer to purchase One (1) HME Ahrens-Fox Pumper truck in the amount of \$510,273.00 with funds from the Public Safety Fund, contingent upon the legal opinion of the Township attorney. Swimming Pools: Malkin reported that there was a recommendation from the Planning Commission to repeal the Swimming Pool Ordinance #18 primarily because of inconsistencies with the building code which creates a conflict. In further review and comparison it was discovered that there are setbacks which are not currently covered under our Zoning Ordinance because this is a freestanding Ordinance. By advice of the Township Attorney, it was advised to wait until the Planning Commission completes the Ordinance review and addresses the items which would not be covered before repealing.

Dangerous Buildings: Malkin reported that he after consulting the Zoning Ordinance; it doesn¢t appear that we have an Ordinance that covers dangerous buildings. The Board discussed various situations where the Township could benefit from developing and approving a dangerous building ordinance.
