# <u>Planning Commission Inquiry Regarding Ordinance for Medical Marijuana</u>

Reder stated the Planning Commission is requesting board direction before proceeding with a draft medical marijuana ordinance. Rederøs opinion is for the township to not adopt such an ordinance.

Walsh agreed.

Kochany stated many townships are adopting an ordinance for the revenue they could receive but Kochanyøs opinion is the potential costs out way the dollars gained.

Malkin stated licensing the dispensaries guarantees the product purchased by those who need it. Malkin stated if the township only has one dispensary, the township would incur a lot of cost to develop the ordinance and it is unknown if one business would be enough to recoup the cost. Sheppard stated there are other license fees that could generate revenue as well as potential revenue from the state. The township does though have the option to opt out.

Brandt stated a concern he has had is that we do not currently know where the product is being currently grown. There have been instances where the fire department has been called as a result of marijuana being grown in basements.

Sheppard stated the statute going into effect in September would eliminate the õbasement growerö.

Malkin stated there is nothing in the statute that states if we opt out now, we could not later opt in. It may be advantageous to wait and see what happens after the statute has been in place for a year.

Motion by Kowalski supported by Pike to direct the Planning Commission to table development of a Medical Marijuana Ordinance at this time.
