Public Input

Chairman J. Frank opened public comment at 7:01 pm.

Gary Gellise 2353 Midland Road reviewed Wind Turbine meeting at Wirt Library and comments made by T. Miller. He told T. Miller that he needs to be removed from the Planning Commission and that it was not a threat it is a promise.

- R. Sheppard told G. Gellise that is two (2) minutes for public comment had ended.
- J. Bellor made a motion to allow G. Gellise to continue to speak.
- J. Frank accepted the motion and allowed G. Gellise to continue.
- G. Gellise went on to summarize the recall of the Kawkawlin Township Supervisor because he was pro-turbine in a non-pro turbine township. He told Ken Malkin, Supervisor that he wants T. Miller removed and he will see that it happens. G. Gellise stated that Monitor Township can not vote for the Planning Commission, but the township can vote for Malkin.

Special Use Permit & Site Plan Review

VIRIDIS North Parcel ID: 09-100-V07-000-027-00 1424 Straits Drive: RE: Marihuana Compliance Laboratory

Bill Bartlett-Corporate Manager of Straits Corporation, 1424 Straits Drive gave a review of the project and handed out responses to site plan review made by the planner, G. Elliott and engineer-J. Wheeler.

B. Bartlett revised the building square footage to 13,606 square feet not 14,600 square feet as originally submitted.

- B. Bartlett stated that they may look for a second tenant to share the building but it has not yet been determined. He went on to explain that the exhaust stacks will not extend above the roof peak.
- B. Bartlett reviewed the current landscaping with G. Elliott.
- B. Bartlett handed out a security plan and explained it was presented to Monitor Township Board of Trustees.
- B. Bartlett reviewed odor control. He explained the lab samples are small, 15 to 20 milligramsevery sample is completely homogenized and treated. The samples are not heated. All the samples are non-distinguishable and non-useable and when testing is complete, they are bagged and picked up by a third party.
- R. Sheppard suggested to tie in a review process with the annual license renewal.

Motion by J. Bellor, seconded by B. Reder to open public input. **Motion carried**

Carole Hoyle, 5184 Three Mile asked B. Bartlett how neighbors in the park feel about the lab.

B. Bartlett responded that he has received no negative comments.

Motion by J. Frank, seconded by T. Miller to close public input. **Motion carried**

Motion by B. Reder, seconded by J. Bellor to approve Special Use Permit and Site Plan Review with the following conditions:

- 1. No waste or water discharge of product into public systems
- 2. Only traditional water discharge would be public restrooms, kitchens, etc.
- 3. Applicant acknowledges the second special use permit and site plan review is necessary if an additional tenant will use the other half of the building --even if the tenant is not marijuana related.
- 4. Reserve the right to require odor control mitigation program, in the event the Township Board becomes aware of odor migrating from the property.
- 5. Must maintain compliance of the Site Plan in order to maintain the Special Use Permit.

R. Sheppard reviewed Section 3.12 of Zoning Ordinance 67, Clear Vision Corners.

Sheppard suggested revision would be the same restrictions apply regarding any driveway, private street, private lane or property lines requiring a clear vision corner twenty five (25) feet back from the mutual property line at the road right-of-way and twenty five (25) feet along the road right-of-way line and mutual property line creating said triangle.

R. Sheppard reviewed Section 3.22 of Zoning Ordinance 67, Keeping of Pets and Livestock.

It was decided among the committee members not to revise the ordinance.

T. Miller distributed an article on Michigan farmland and solar power.

C. Schweitzer stated the Solar Energy Committee has reviewed several solar ordinances from throughout Michigan to be used as a guideline in drafting Monitor Township Solar Ordinance.

A discussion continued among the members regarding changes made to draft revision sections 5.05, 3.27, 3.12, 3.22. R. Sheppard stated that G. Elliott will create a packet with revisions for review, but until Solar Energy is completed, no Public Hearing date will be set.

Motion by B. Campbell supported by T. Miller to adjourn. Motion carried.
