PLANS NOT REQUIRED FOR THE FOLLOWING

1. One and two family dwelling containing not more than 3500 square feet of building area.
2. Alterations and repair work determined by the plumbing official to be a minor nature.
3. Buildings with a required plumbing fixture count less than 12.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.

PLANS NOT REQUIRED

PLANS ARE REQUIRED for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA299 and shall include the architect's or engineer's seal and signature.

CODE OFFICIAL _____

Section 23A of the State Construction Code Act of 1972, 1972 PA No. 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of Section 23A are subject to civil fines.

HOMEOWNER AFFIDAVIT: I hereby certify the plumbing work described on this permit shall be installed by myself in my own home in which I am living or about to occupy. All work shall be installed in accordance with the State Plumbing code and shall not be enclosed, covered up or put into operation until it has been inspected and approved by the Plumbing Inspector. GENERAL: Plumbing work shall not be started until this application for permit has been filed. All installations shall be in conformance with the State Plumbing Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED. UPON CANCELLATION A NEW PERMIT IS REQUIRED
