## CHARTER TOWNSHIP OF MONITOR REGULAR TOWNSHIP BOARD MEETING July 26, 2021

The Supervisor called the meeting to order at 7:00 p.m.

Public input opened at 7:01 p.m.

T. Kloha, 2514 E. Salzburg, discussed the efficiency of glass on the new Fire Dept. doors and requested a copy of the August ballot wording for the Fire Dept. bond.

D. Hughey, 2693 Royal Oak Dr., discussed blight at 2683 Royal Oak, and the complaint filed a month ago.

N. Niederer, 5402 Elmview, stated he lives next to the blight house the past 28 years and it is unacceptable.

J. Flathau, 5492 Goetz Ct., added that the blight house has live traps on the roof.

K. McMullen, 5430 Goetz Ct., said he is concerned about children playing in it.

C. Hughey, 2693 Royal Oak Dr., mentioned she has had to shoo children away.

D. DeGrow, 8086 Hawk Dr., Freeland, stated his wage request was denied at the last meeting based on the Zoning minutes from Oct. 2020 that he wasn't even aware of. He clarified that the previous Supervisor ordered him to stay out of zoning. So the problem that the minutes referred to was not with him.

D. Scherzer, discussed that the Sanitary Sewer, SRF project was submitted for reimbursement. Fisher contracting is scheduled for August 23<sup>rd</sup> for the manhole work and lining the pipes with completion in July of 2022.

Stein Park-hoping to hear soon on receiving the grant by June 2022 with construction in 2023.

R. Walsh, Planning Commission report included approving MI Sugar for a new site plan addition.

Supervisor reported that the American Rescue Plan Act application was submitted. The County Sheriff Cunningham came to the office for a meeting with Spencer, Pike and Ferguson. The township survey was extended until August 31<sup>st</sup> since only 150 were returned so far. The public has had positive comments about the fire station construction but now the hall needs updated. He explained the blight complaint on the Royal Oak house just came in on June 30<sup>th</sup> and the paperwork has been submitted to the building official. Complaints about the trailer are being addressed too, he is on it.
