T. Keyes, of Bay Future presented to the Board the Monitor Industrial Park Pavement & Utility Improvements plan as prepared by Spicer Group. The site is 192 acres and located east of the existing Certified Tech Park and is identified as a Michigan Site Readiness Program site. A \$100,000 grant paid for this work to be completed. **Correction this grant needs to be submitted to reimburse the township for this expense per R-2020-001.

Motion by Pike supported by McCulloch accept the bid from Waste Management for the 3-year contract to include the recycle rollout cart starting at \$16.00 per unit per month.

Norton, from Spicer, discussed how closing the lines provides better water and fire protection to the area.

Motion by Pike supported by Walsh to request 10 copies and charge AEY Capital LLC \$5,000 to transfer the permits to Thrive Enterprises LLC, a wholly owned subsidiary of AEY Capital. This is contingent upon acquiring State approval for the same.

D. Scherzer, Spicer, explained the manhole work started August 9th, Sanitary Sewer is scheduled to start Oct. 4th, with completion expected in July of 2022. Steih park was awarded a 345 score this year and last year it was 340, it is unknown if that will qualify for the grant money that will be decided in December. Fire Station is still under budget and the Open house is Oct. 10th. Sunday asphalt was laid. Lockers will be arriving late.

R. Walsh, Siltron site plan was approved. A Oct. **Sept. 28th 4:00 meeting to consider Special Use for an extra 9' of building is scheduled.

T. Spencer introduced our new sheriff deputy Austin Jobes. The Fire Dept. open house is Oct. 10th from noon to 3:00. Serenus, Spicer, and WTA Architects have donated to it. He toured Siltron and explained how they are already working with Delta college and will be offering jobs with benefits. He congratulated T. Keyes on his award from Bay Area Chamber of Commerce for the Leadership Alumni Community Service Award. He Suggested that a speed indicator sign be placed near MacAlear-Sawden in the future. Vandalism at the Township Park was cleaned up. He is getting an estimate from Strategic Security Camera but connectivity is an issue. A food drive is being held at Quantum Composites, 1310 S Valley Center Dr. (in Tech Park) from Oct 1st – 14th. Oct. 28th Versiti will be at the township for a blood drive. The next B.C.T.O.A. meeting will be on Oct. 20th at Williams Township Hall. Spicer has prepared a free concept drawing of the south side of the township offices and left it on the table for public viewing. It illustrates a visual for bringing the township offices up to date and matching with the new fire dept.
