**ORDINANCE NO. 15-V**

AN ORDINANCE TO ADOPT BY REFERENCE THE INTERNATIONAL FIRE  
CODE OF 2015.

THE CHARTER TOWNSHIP OF MONITOR, COUNTY OF BAY, STATE OF MICHIGAN  
HEREBY ORDAINS:

**SECTION I**

That the Charter Township of Monitor, County of Bay, State of Michigan, hereby adopts by reference the 2015 International Fire Code and as it may be amended from time to time.

That the Charter Township of Monitor shall administer and enforce the Code hereby adopted.

**SECTION II**

That the fees as incorporated in the Code hereby adopted are also adopted by reference, except as such fees have been previously established and amended by Resolution of the Township Board.

That such fees as hereby adopted may from time to time be amended by Resolution of the Monitor Township Board.

**SECTION III**

That any violation of the Code hereby adopted shall upon conviction subject the violator to a municipal civil infraction as to described in Ordinance 53, previously adopted by this Township.

**SECTION IV**

That any Ordinances or amendments thereto that are in conflict with this Ordinance adopted by reference are repealed.

**SECTION V**

That if any section, subsection, sentence, clause, or phrase of this Ordinance or the Code adopted by this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Charter Township of Monitor Board hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase therefore, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases may be declared unconstitutional.

**SECTION VI**

That this Ordinance shall be published in a newspaper circulated within the Charter Township of Monitor, Bay County, Michigan. Further, that a certified copy of this Ordinance be mailed by certified mail to the Bureau of Fire Services, within five (5) days after enactment.

**SECTION VII**

That this Ordinance shall become effective on the day after its publication.
