Sheppard provided comment regarding the application and language in existing ordinance (Section 5.03) (m). He asked the commission if it should be addressed by the Planning Commission or Zoning Board of Appeals?

Littman responded with comments on his interpretation of the existing language. He does not feel this would be permitted according to Ordinance 67.

Jackson commented if it was a viable use and where it should be allowed.

Rosenbrock commented on the facility on Wilder Road and that no product should leave the facility.

Sheppard recommended that the application be sent to the Zoning Board of Appeals to determine if it is a permitted use or not.
