Motion by Arnold seconded by Pike to approve the Electronic Communications and Internet Use Policy with the addition of referencing the Personnel Policy for disciplinary measures. Motion unanimously carried.

Motion by Ferguson seconded by Walsh to pause on page 5 of the Social Media Policy draft and approve the remaining agenda for discussion.
